Self-certification regarding the implementation of Article 3i(1), Article 3o(1), (2) and (3) and Article 3p(1) and (2) of Regulation (EU) No 833/2014 in accordance with the requirements set out in Council Regulation (EU) No 2024/1469 of 21 May 2024.

- 1. In accordance with Annex XXI of Regulation (EU) No 833/2014, it is prohibited to purchase, import or bring into the Union, directly or indirectly,
  - a) Silver (including silver plated with gold or platinum), in its raw state or as a semifinished product or powder,
  - b) Articles of precious metals or of metal clad with precious metals, n.e.c,
  - c) Synthetic or reconstructed precious or semi-precious stones, whether or not worked or graded but not strung or mounted or set; synthetic or reconstructed precious or semi-precious stones, not graded, temporarily strung for convenience of transport, which generate significant revenues for Russia and thereby enable Russia's actions destabilising the situation in Ukraine, to be purchased, imported or spent, directly or indirectly, in the Union, if they originate in or are exported from Russia.
- 2. In accordance with Annex XXVI of Regulation (EU) No 833/2014, it is prohibited
  - a) to purchase, import or transfer, directly or indirectly, if it originates in Russia and was exported from Russia to the Union or a third country after 22 July 2022 (Art. 3o(1) of Regulation (EU) No 833/2014).
  - b) To purchase, import or transfer gold directly or indirectly if it has been processed in a third country using gold that is prohibited from being imported into the Union (Art. 3o(2) of Regulation (EU) No 833/2014).
  - c) To purchase, import or transfer, directly or indirectly, exported gold (jewellery and parts thereof, articles of jewellery and parts thereof) if it originates in Russia and was exported from Russia to the Union after 22 July 2022 (Art. 3o(3) of Regulation (EU) No 833/2014).
- 3. In accordance with Annex XXXVIIIA, Parts A, B and C of Regulation (EU) No 833/2014, it is prohibited
  - a) To purchase, import or transfer, directly or indirectly, diamonds and products containing diamonds if they originate in or have been exported from Russia (Art. 3p(1) of Regulation (EU) No 833/2014).
  - b) In accordance with Art. 3p(2) of Regulation (EU) No 833/2014, To purchase, import or transfer the above-mentioned goods if they have been transited through the territory of Russia.

We hereby certify that we are aware of the foregoing prohibitions and that none of the products in question are used by us or within our entire supply chain. We further certify that we do not import or process any of the foregoing products or import goods in which the sanctioned products are processed.
